- Leadership in NDAAP's early brain child development partnerships with home visitors Kathy Anderson, MD

ND HPV Project Update

We submitted and received a \$15,000 grant from the AAP to participate in an HPV project. ND is partnering with MN, SD, and other District VI chapters on this grant (each has been awarded \$15,000).

Goals of the project:

1.) Train 30 pediatricians, family physicians, nurse, PAs, NPs, pharmacists, and residents/trainees in providing a strong provider recommendation for HPV administration and documented increase in knowledge and planned activities.

2.) Increase rates of 1st HPV vaccination administration among 11-12 year old boys and girls by 10% from baseline through implementation of a clinic-based QI effort in at least 2 ND clinics

3.) Increase rate of 2nd and 3rd dose of HPV among 11-12 year old boys and girls from baseline through implementation of a clinic-based QI effort in at least 2 ND clinics

4.) To develop, in partnership with pediatricians in District VI, an HPV MOC4 module that can be used nationally by participating pediatricians

5.) To develop, in partnership with pediatricians in District VI, an HPV MOC2 module that can be used nationally by pediatricians

Measures:

Number of individuals trained, by profession and pre- and post-test results from training
Utilizing the state immunization registry, reporting baseline clinic data on HPV by participating clinic;
utilizing the HPV MOC4 module and the AAP QIDA system, report participant QI results from baseline, through audits and final results for HPV administration in 11-12 year olds served by clinic;
Types of enduring HPV training and QI resources developed and available/distributed during the project period including archived learning collaborative conference calls/webinars for project participants in the district-wide virtual learning collaborative.

To date, we are partnering with District VI Chapters and working with the National AAP on MOC 2 & 4 and will use Quality Improvement Data Aggregator (QIDA) for data collection. Kylie will be disseminating information on "Someone You Love: The HPV Epidemic" which will contribute to fulfillment of measure 4. The next step is to get practices signed up and identify a practice leader – we began doing this at the spring meeting but we need to get agreements completed.

Chapter MOC requirements are to input data into QIDA on a monthly basis for 3 consecutive months. The sampling strategy is 10 charts of consecutive eligible patients seen that month OR all patients who meet the criteria.

Kylie will send out the movie, Someone You Love: The HPV Epidemic" to use as training. Please watch and share with others in your practice. Also, notify Kylie when you have watched it and the number of other people in your practice who have watched it so that we can report it.

When we receive more information from the others we are working with on this grant we will send out a "script" to the Practice Leaders and also a form that can be used by providers.

Pediatricians who are not AAP members can participate and are eligible for MOC credit, we will need to create a temporary AAP ID for them to access the QIDA platform. You are welcome to ask them to join the Chapter to participate, but on our end, it is not actually required, although we can only grant credit to pediatricians. Family Physicians (obviously not AAP members) can participate but will need to submit their activity to the ABFP to request MOC credit (we cannot grant them credit).

HPV efforts, meningococcal B vaccine, and other immunization issues Molly Howell

Child Care Aware of North Dakota

Mari Quittschreiber is an inclusion specialist that Sarah brought with to the meeting today. There are only two inclusion specialists in the state. Inclusion Specialists are for child care providers that are caring for children with specials needs.

Even when the grant funding runs out there is a waiting list for funds, but Mari and Missy are still available to come out and provide technical assistance.

They encourage daycares to incorporate early child education into their facilities. They provide funding to assist daycare providers in getting their CDL.

Tobacco Free ND

Erin Hill-Oban

Work with BreatheND and the Dept. of Health. TFND Goals for 2015/1016 include increasing ND's tobacco tax. NDAAP was a supporter for a bill related to this last legislative session. Erin would like to come talk to NDAAP about what they can do to pass an increase in tobacco tax during the next legislative session.

Results of a provider survey that was administered by BreatheND about the implementation of the 5 A's (ask, advise, assess, assist, arrange) or AAR (ask, advise, refer) was discussed. ND Quits is a great referral place for those that don't some a service in-house.

Legislator's impressions of access to care. Expanding prescriptive privileges to naturopaths was a big concern of the NDAAP. We want to increase access to providers but in a way that is safe for patients.

The NDAAP will lead with the ND Department of Health's support will pursue getting nurses in schools. So, since there is such a workforce shortage of nurses, telemedicine may be the answer. Most school nurses are funded through school districts.

Todd Twogood will take the lead on this. Kylie will check with the Center for Rural Health about possible telehealth grants they might know of and the North Dakota Rural Health Association may also be supportive of this initiative. Kylie will look into USDA and HRSA grants for this and also look at the Georgia and other models.

Doctors On Demand has some physicians from ND on it. Joan Connell is trying to find out who the ND physicians are.

• Medical Marijuana

Joan is trying to figure out how to get pharmaceutical compounds that have products derived from marijuana to treat patients that need them.

If you tell Joan what conditions you would like to use marijuana biproducts for and she will try to find a PI for clinical trials to get kids the treatments they need. Dr. Parachuri, Peds Neurologist from Sanford, is in the process of becoming a PI now.

There are big issues with legalizing medical marijuana in the state because there won't be the research on it, dose appropriately, etc. NDAAP wants pharmaceutical marijuana – FDA to change it from a schedule 1 to a schedule 2 drug so that physicians are able to access it easier and dosage to be tested and studied in patients.
